**REPORT AND RECOMMENDATION**

Before me is Plaintiff's Unopposed Motion for Attorney's Fees Pursuant to the Equal Access to Justice Act (doc. 25).<sup>1</sup> Plaintiff seeks payment of attorney's fees in the amount of \$7,537.46 to be paid directly to Plaintiff's counsel pursuant to the EAJA.<sup>2</sup> On December 27, 2017, the District Judge entered an Order adopting my Report and Recommendation and remanding this case for further proceedings (doc. 23); judgment in Plaintiff's favor was entered the next day (doc. 24).<sup>3</sup>

In *Reeves v. Astrue*, 526 F.3d 732 (11th Cir. 2008), the Eleventh Circuit held that an EAJA fee award is awarded to the "prevailing party," not to counsel. However, in this case, the Plaintiff has agreed to assign the EAJA award to her counsel (doc. 27), and Plaintiff indicates that the

<sup>2</sup> The amount Plaintiff seeks in fees represents 38.2 hours of total attorney time. Specifically, attorney Enrique Escarraz requests fees at the rate of \$188.47 per hour for 0.5 hours of work performed in 2016, \$197.32 per hour for 36.8 hours of work performed in 2017, and \$199.48 per hour for 0.9 hours of work in 2018 (doc. 25).

<sup>3</sup> The plaintiff in a social security case has 30 days beyond the 60-day appeal window to apply for fees and other expenses under the EAJA, for a total of 90 days after judgment. *See* 28 U.S.C. § 2412(d)(1)(B), (d)(2)(G); Fed. R. App. P. 4(a)(1)(B); *Gates v. Barnhart*, 325 F. Supp. 2d 1342, 1343 (M.D. Fla. 2002). In this case, Plaintiff timely filed her application for fees on March 23, 2018 (doc. 25).

Defendant does not oppose the request for attorney's fees. Therefore, by virtue of the fee assignment and the Defendant's lack of opposition, the award is payable to Plaintiff's counsel.

Accordingly, I RECOMMEND:

1. Plaintiff's Unopposed Motion for Attorney's Fees (doc. 25) be GRANTED; and
2. Plaintiff be awarded attorney's fees in the amount of \$7,537.46, to be paid directly to Plaintiff's counsel, if Plaintiff does not owe a debt to the Government.<sup>4</sup>
