ORDER

Petitioners filed this action to confirm an arbitration award entered in their favor against Respondent. (Doc. 1.) The Court granted the Petition (Doc. 25) and judgment was entered in Petitioners' favor (Doc. 26). Petitioners now seek attorneys' fees in the amount of \$27,454.40. (Doc. 29 ("**Motion**").) Respondent did not respond to the Motion.

On referral, U.S. Magistrate Judge Thomas B. Smith recommends granting the Motion in part to award Petitioners \$7,564 in attorneys' fees based on hours that would reasonably be expended on this simple case and fairly allocated to Respondent. (Doc. 30, pp. 7–10 ("R&R").) The parties did not object to the R&R, and the time for doing so has now passed. As such, the Court has examined the R&R only for clear error. *See Wiand v. Wells Fargo Bank, N.A.*, No. 8:12-cv-557-T-27EAJ, 2016 WL 355490, at *1 (M.D. Fla. Jan. 28, 2016); *see also Macort v. Prem, Inc.*, 208 F. App'x 781, 784 (11th Cir. 2006). Finding no such error, the Court concludes that the R&R is due to be adopted in its entirety.

Accordingly, it is **ORDERED AND ADJUDGED** as follows:

- 1. U.S. Magistrate Judge Thomas B. Smith's Report and Recommendation (Doc. 30) is **ADOPTED**, **CONFIRMED**, and made a part of this Order.
- Petitioners' Motion for Attorneys' Fees (Doc. 29) is GRANTED IN PART
 AND DENIED IN PART:
 - a. Petitioners are **AWARDED** \$7,654 in attorney fees.
 - b. In all other respects, the Motion is denied.
